Bidders shall deem to include the cost of providing FASTag-grade RFID readers at each entry and exit point, along with middleware, configuration, integration, testing, and commissioning, as per provisioned BOQ items specifically provided in

			the RFP, which shall also include <i>Integration with Existing Systems, Installation, Testing & Commissioning</i>.
2	RFP Section 6 – Scope of Work Clauses 6.2.1(d), 6.3.3, 6.4.6	FASTag-based parking operations mentioned in the Scope of Work.	It is clarified that FASTag-based parking operations are mandatory for this project as per RFP Section 6 – Scope of Work (Clauses 6.2.1(d), 6.3.3 & 6.4.6) . The proposed system shall include FASTag-grade RFID readers compliant with NETC / IHMCL / NHAI guidelines , including backend software, cloud infrastructure, and payment gateway integration.
3	RFP Section 6 – System Integration & Commissioning Clauses	Cost responsibility for retrofitting of existing infrastructure not explicitly detailed.	As per RFP provisions on system integration and commissioning , all costs related to retrofitting / upgradation of existing parking infrastructure , including boom barriers, ANPR cameras, controllers, and FASTag enablement, shall be deemed to be included in the quoted BOQ price, and no additional payment shall be admissible .
4	RFP – Bid Submission & Compliance Requirements	Multiple declarations required at different locations in bid submission.	As per the Bid Submission requirements of the RFP , bidders may submit a single consolidated declaration covering compliance with all BOQ items and Scope of Work requirements , which may be uploaded at all relevant locations on the GeM portal wherever required.

General Clarification

- The “**Scope of Work** as detailed in the RFP shall prevail over the BOQ in case of any omission or ambiguity.
- Bidders are required to ensure **end-to-end FASTag-enabled parking functionality** as per RFP requirements.
- No additional financial claim on account of FASTag RFID readers or related integration shall be entertained at a later stage.

All other terms and conditions of the RFQ-cum-RFP shall remain **unchanged**.
